





The passenger must present himself at the check-in for boarding in advance of the departure time as better specified in paragraph 11 of the General Conditions of Transport.

VEHICLES ACCOMPANYING PASSENGERS:

Regarding Tunisian lines, extra high vehicle heights are solely permitted for cars which enter/leave Tunis and for campers/vans which leave from Tunis. Conversely, extra-high vans and campers heading for Tunisia are no longer permitted, as such vehicles with roof luggage are no longer allowed to unload at the port of Tunis.
